Wildlife and Heritage / Biodiversity Conservation

Overview and history of serpentine ecosystems at Soldier's Delight Natural Environmental Area (SD NEA)

Invasive Species issues at SD NEA

- invasive species took over 3 years ago accumulated non-serpentine organic soil from conifer invasion created environment favorable to invasives; 16 species from MISC list have been found.
- invasive species management competes with conservation efforts.
- ongoing restoration of 1000 acres through prescribed burning.
- need MISC brochure to educate residents of new housing developments near SD NEA.

Discussion

- air quality, smoke management concerns with prescribed burning in winter cut down old, dead, broken trees that act as chimneys; local residents are supportive; 911 calls reporting burnings are a problem.
- Virginia pine is an example of native invasive that leads to non-native invasions.

Anne Hairston-Strang MD DNR FS - interested in forest buffer establishment, how to control invasives.

Meredith Malone, TNC, Land Steward - Weed Watchers program specialist in summer; filling in on MISC for Donnelle Keech.

Laura Stedman, MD SHA - works with Don Cober; vegetation management in right-of-ways where invasives move in.

 Larry will pursue bids and report back via list serve; first printing should be small so corrections can be made.

Fifth issue: Invasive Species

- MISC has contributed material on gypsy moth, weeds (MD noxious weeds, tropical soda apple, *Microstegium*, multiflora rose), MISC description, representation, and list.
- need volunteers to help train teachers and students
- initial deadlines have passed but MISC can develop more material for state winner to prepare for national competition

Discussion

• tropical soda apple not on Maryland list - list is not inclusive, competition is international.

Committee Reports

Organizational - Carol Holko

- passed out summary of Organizational Committee (OC) activities to date.
- Motions to be considered and voted on at next meeting.
 - 1. One third of the membership is required for a quorum.
 - 2. Terms for facilitator/recording secretary will be renewable annually in April.

Either the facilitator or recording secretary may step down, or a member may nominate a replacement. The OC will be responsible for nominating a replacement in the former case. Alternates will be selected by acting facilitator/recording secretary.

- 3. New attendees requesting voting privileges need to be present twice to be voted into membership and must be present for vote to proceed.
- 4. If a member is inactive for one year, membership will be suspended.
- Alternate facilitator is currently Bill Gimpel. Alternate recording secretary is currently Larry Hurley.

OLD BUSINESS

Plum Pox - Bill Gimpel

- no detections in Maryland in 2001.
- Pennsylvania detected 15 miles W. of previous area; found in homeowners yards; destroying positive trees and buffer areas.

Daylily rust - Bob Trumbule

• isolated detections of daylily rust in Maryland; plants destroyed; pictures available.

Red imported fire ant - Bill Gimpel

- continuing to treat, but not 100% control in Bowie site.
- detected in 3 additional landscape holding yards in stock imported from quarantined areas in southern states.

NEW BUSINESS

American Seed Trade Association (ASTA) letter to MA-EPPC

- threatens legal action if crown vetch is included on MA-EPPC invasive species list.
- ASTA was invited to be on MA-EPPC board, but declined.
- MISC likely to be targeted when list is published because many regulatory agencies are involved; need to make point that this is not a regulatory list.
- Malcolm Sarna is in contact with seed groups; species related to agricultural crops (orchard grass, timothy, etc.) are not on our list; doesn't anticipate a problem.
