Northern snakehead - found in privately-owned pond in Crofton, Maryland

- CANNOT walk or burrow into mud, CAN survive freezing temperatures, 3 ft. maximum size; food, not aquarium, fish; released intentionally and illegally, 2-year statute of limitations on prosecution.
- killed vegetation, applied Rotenone killed 5 adults, 800 young, i.e. reproducing population.

- current status appears to be gone; electroshocking yielded only one bullfrog, will restock in Spring.
- brought invasive species issue to everyone's living room.

#### Mute swan

- almost finished management plan, future uncertain.
- most recent public comments favorable for plan, some previously against in task force report.
- plan slowing growth of population, egg addling, 300 nests in 2002.
  - concentrated in mid-Bay area.
  - 95% cooperation from landowners in affected area.
  - survey every three years, 2002 survey indicates slowing of growth.
  - research, 1)impact on SAV, 2)impact on tundra swans.
  - proposed restrictions on sale, importation, breeding, and possession.
  - plan included on DNR web page.
- Discussion: are landowners responsible for populations on property? possession means keeping in confinement; originally brought in as domestic.

### Nutria - brought in for fur farming in '40's

- population 50-75K ?; reproduce all year; young can eat on own in 4 days; reproductive @ 4 months; 4-13/litter.
- destroy 1000 acres of swamp/year restoration pointless without controlling nutria; move maximum of 40 acres/day; will destroy habitat and move on; general vegetation feeders; don't eat Phragmites.
- pilot project in Dorcester County over; 14 trappers hired through APHIS; 800 nutria caught since September; hired 2 landowner liaisons.
- goal to eradicate nutria expensive, feasible?, need congressional support Discussion

non-targets? - caught, not generally harmed in leg hold traps; rails caught in kill traps during migration - traps modified and non-target rail kill reduced; racoons and muskrats also caught - traps checked daily. Natural predators? - none when adults.

# National Aquatic Invasive Species Act

• screening, rapid response emphasized; puts time limit on ballast water exchange, will be introduced next session; important to comment when asked.

### Discussion:

Are any invasive plant projects underway? - no, Jonathon McKnight is current lead DNR person for invasive species.

Should we draw legislative persons into group? e.g. Delegate Baldwin, Senator Frosh, staffer David Bruster - formal invitation to provide input on opportunities for legislative changes?; Edie could facilitate identification of issues, present overview, top issues to be addressed through statutory change; need specific issues to present to legislators; Environmental Day - apprise legislature of MISC and MISC issues, i.e briefing.

Other success stories? Phil Pannell, SHA - Ailanthis suppression.
