<u>Presentation</u>: Match the Hatch: Getting the Right Message in the Hands of the Right Reporter, Candus Thomson, Outdoor Writer, Baltimore Sun

- e.g. IPM Center Conference where is the press?
- Answer the question "So What?"
- · Contact reporter directly
  - follow up with reminder
  - use communication method of preference (email, snail mail, phone)
  - exchange cell phone numbers
- Put out information sheets make it easy
- Provide lists of experts
- Sell your story, provide adequate information
- Do your interview on Sunday to get the top of the news Monday is always slow
- Do what you are comfortable with don't try to strike up a relationship with a reporter in the middle of a crisis
- · Reporters like field trips
- Don't give up if 1st time doesn't work or a bad reporter experience
- Update press release lists identify appropriate contact; outdoor, gardening, environmental reporters
- Keep press releases to one page; use short words; answer the question "so what?"
- Be careful of "off the record" (OTR)

- establish ground rules, don't assume all reporters will honor OTR
- OTR information cannot be used not the same as anonymous source
- Try zoned editions if main paper doesn't respond
- Discussion
  - How to cover bad news? Control the message don't leave it up to the bloggers
  - IPM Center conference PSA was sent out to COSDA what else to do? Pick up the phone and call
  - IOM too cutsie? Bigger problem: information isn't getting to right person
  - DNR gets message out MDA will add names to press list
  - Request sit-down interview on invasive species with section editor send nongovernment MISC representative; refer to govt. experts

- 2005 NISC activities:
  - revise National Management Plan
  - Report to OMB on progress per Executive Order
  - Upgrade and enhance information dissemination
  - definitions white paper clarifying Executive Order terminology and definitions, i.e. what they don't mean (NISC is not regulatory)
  - NISC working on Invasive Species Compendium with CABI
- · Remain optimistic in spite of budgets

## DNR - Jonathan McKnight, Steve Early

- "Black Salty", new species marketed to fishermen as bait, is feeder goldfish, already introduced throughout Maryland; not a threat DNR will run informational campaign; is legal to introduce anything that's on a hook into MD waters
- Mid Atlantic Regional Panel In Federal Register Bob Tichenor is MISC rep, Jonathan is DNR rep.; clearinghouse for mid-Atlantic policy and funding
- Don Webster, manages phragmites cost share program on Eastern Shore sprayed over 1700 acres, >500 on public land, ~1200 private for 600 landowners; effective in previous years; no restoration needed, natives move back in; MDA conducts spray activities for program

- Maryland has formed soybean rust team and planning document; pathogen probably didn't overwinter in US, will blow in from Central America; MD will likely see late season infection if at all; modeling and prediction developed by NC State; real time monitoring framework effort being led by USDA APHIS; MDA will post information on MDA's Web site, speaking of which...
- MDA has new site and server; check us out at http://www.mda.state.md.us
- Emerald ash borer
  - Canadian ash free zone = 10 kilometers x 30 kilometers, all ash trees removed to

prevent spread - outliers found after eradication; potential to use solitary wasp to detect outliers

- Michigan outliers all over state; "gateway approach" to focus on specific areas; entire state generally infested; populations found in Ohio and Indiana; underfunded; if contained in MI, OH, IN, populations may burn themselves out
- MD will target campgrounds with campers from MI, OH, IN and put up trap trees

Sara Tangren - sawtooth oaks easy to identify now, similar only to southern red oak; heel shape at back of leaf; older trees lose leaves at top, younger trees keep all leaves; consider to list as invader, populations still at levels that can be contained

Discussion:

- bacterial leaf scorch is threatening native red oaks sawtooth oak could fill in gap
- acts invasive like oaks, but is not displacing native oaks
- culturally and economically valuable
- shading from winter leaf canopy is potential problem for understory

Motion to form a sub-committee to study sawtooth oak as potential listed species. Motion seconded and passed.

No precedent - i.e. future list nominees not locked into committee evaluation unless controversial
