- Assessment: adapted Nature Server assessment tool impact on natives, habitats and ecosystems, current distribution and abundance, potential to increase and spread, difficulty of management, other, bibliographical support
- Categories: 1) Widespread and invasive, 2) Restricted and invasive
- Official lists handout
- Purpose of list?
- How to regulate noxious? plant pest? nuisance? invasive?
- Decision to work with industry, visited Behnke's "Take a Closer Look" program
- emphasize alternatives to invasive plants
- Governor's initiative "Livable Delaware" led to...
- "Plants for a Livable Delaware" = adaptable characteristics, no potential threat (not necessarily native), no serious disease or insect problems, hardy to DE
- Passed out booklet, *Plants for a Livable Delaware*, lists alternatives to invasive plants no photos of invasives, just alternatives
- signs, logos for three cooperating nurseries in 2004
- companion booklet Controlling Backyard Invaders
- companion pamphlet Participating Businesses
- programs funded by mini-grant civic and non profit associations, schools, parks
- Next? Designing with Livable Delaware Plants pattern book for landscaping models

Discussion:

Approach "big box" garden centers? - Corporate management and coordination is problematic DISC focus only on plants? Includes all taxa, but small size forces focus on invasive plants; CAPS takes care of insect problems, presents at DISC annually

"difficulty to manage" puts plants higher on invasive plant list

Assessment? Will evaluate

Expansion of program - additional facilities signed up at Nursery and Landscape Expo Legislation needs to be enforceable

Visit http://www.nationalplantboard.org for state noxious weed lists

Work with State foresters? Yes, to distribute literature

Prevent future invasive problems? Inquire about invasive potential; Q-37 may address this by establishing risk categories, prohibited pending risk assessment

Native vs. exotic? Emphasis on invasive v. non-invasive

Potential for similar Maryland program? Has considered expanding to other states.

Nuisance Plant Law, SB283, 105th legislative session - specific plants must be contained, warnings posted in nursery; law describes how plants can be added or deleted; committee appointed by DE Department of Ag.

Updates:

MDA - Dick Bean, Carol Holko, Bob Rabaglia

- HWA predators recovered *Laricobius negrinus* at Rocky Gap State Park, treatments continue to suppress HWA
- *P. ramorum* nursery perimeter surveys to complement nursery survey, 50 sites across state, ½ complete, testing direct to PCR
- Sirex noctilio, wood wasp native to Eurasia kills pine trees detected in Fulton, NY in CAPS trap, 2004; found some larvae in 2005 tentatively identified, waiting for adult emergence
- SC, GA ambrosia beetle detected in 2002 in trap outside Savannah November 2004, red bay trees dying @ Hilton Head and Savannah; ambrosia beetles and fungus found in dying trees; sassafras also starting to show symptoms in GA; beetles vector fungus; beetles may be restricted to Oraceae, but can other beetles pick up fungus and spread to other families of plants?
- P. ramorum national nursery survey ongoing, no 2005 positives to date
- Soybean rust detection on volunteer soybeans in GA no movement since; survey for kudzu
- Rose rosette disease wild roses, *Rosa carolina*, unhealthy at wildflower farm in Davidsonville, Carol and Bob will follow up

• Heavy populations of *Gallerucella* found in Font Hill Park in Howard Count - every growing tip has 5-7 larvae; one of first release sites

DNR - Kerrie Kyde

- Email from Al Tasker releases of predatory weevils that UD has been working with on mile-aminute in PA
- Mute swan culling pending court ruling this week
- Unofficial approval for PLS PTI grant
- Distribution of Asian clam in MD map passed around; every county except St. Mary's and Charles County
- Homeowners can't do anything to control mute swans legal morass; state says that Federal Law takes precedence; animal rights groups say that International Law takes precedence
