MDA - Carol Holko, Bob Tichenor, Lane Heimer

- Gypsy Moth
  - o 70K acres defoliated
  - o Highest since 1995
  - o Fungal pathogen
  - 90% in Frederick Co. and West, some in Baltimore, Montgomery, Howard Counties
  - o NJ, 320K acres defoliated, ~1/6 of forest resource
- Weed Control
  - Drought slowed down growth and spray efficacy
  - Still treating
  - o W. MD will have to cut down Ailanthus work, already turning
  - o Heavy Phragmites spraying on shore
- Emerald Ash Borer
  - Getting ready for two cuts around detections in 1 ½-2 mile buffer, N (exit holes) and WSW (no exit holes)
  - November 13 practitioner forum, Linthicum MD Carol will post link
  - Pittsburg (Steve Bullington) Cranberry, PA
    - Not eradicating
    - Delimiting and following up on homeowner calls
- SPHD situation
  - Fred Mann relocated to Riverdale

- DNR Anne Hairston-Strang, Kerrie Kyde
  - Invasives present challenges to forest management
  - o Revamping 10-year forest management plans, currently 15 years old
    - Include invasive species assessment and control work prior to cutting
      - (Tichenor) Northeastern Area Association of State Foresters (NAASF) also involved, developing BMP's, e.g. vehicle/equipment washing stations
  - o Invasive Species matrix team weighted toward fisheries but all units involved
    - Objectives: To develop policy and advise secretary on invasive species on state land, support research (e.g. Wavy leaf basket grass)
    - Invasive species Website
    - Poster: Maryland Invasive Species Outlaws posted on Website
    - Co-chairs, Jonathan McKnight, Ron Klauda
  - o Rusty crayfish found in upper Monocacy
    - If heavy, no other crayfish found
    - Probably transported in bait buckets
    - Discussion Are out right bans appropriate? Voluntary approach to trading invasives not working on Internet – compete with local establishments, positive advertising, alternatives

    - Risk assessment likely responsibility of private industry
    - Criteria?
  - ARS/NISC project to identify gaps invasive species knowledge

    - move to all taxa program? Increase political and funding leverage.
- Update on wavy leaved basket grass, Oplismenus hirtellus Kerrie Kyde
  - Nearly covering ~126 acres of Patapsco Valley SP
  - Out-competing Japanese stiltgrass
    - CAUTION pretty pictures of wlbg and jsg can have opposite of desired effect with stakeholders
  - o Perennial, stoloniferous
  - Sticky seeds that attach and are easily transported
  - Evidence that ornamental variegated cv. reverts to aggressive green form
  - Theory that infestation came from landfill, maybe ornamental discarded 10 years ago
  - Eradicated at BARC Marc Imlay's project
  - Need management plan and funding

- o Need mou's between sister agencies relying on EAB plan and following ICS plan
