• Emerald Ash Borer – Bean/Holko

- o Arborists and loggers cleaning up missed trees, cutting in new bump-outs
- Will participate in national survey and continue to survey in EZ; Master Gardeners are helping to find ash trees to fill volunteer certification hours requirement
- First detector training for arborists
  - Cooperative venture with MAA and MCE
  - EAB and ALB will be first "module"
- Exotic Wood Boring Beetle, *Pityogenes chalcographus*, found in trap at Baltimore Importer near port
  - Pest of spruce and other conifers
  - First non-port detection in U.S.
  - Will intensify trapping in Baltimore City and Survey for trees with damage
- Weed Control Heimer
  - Program affected by budget cuts at state and local governments
  - County committee meetings ongoing
- Mile-a-minute weevil Trumbule
  - Next release in July
  - Will collect data after germination

  - 2008 Call for Proposal handed out
  - 12K set aside for regional conference to bring together regional councils
- Feral swine reported from Charles Carroll, Allegany Counties
  - Once established big problem in wooded areas
  - Report pig sightings, shootings to DNR
- Nutria moving teams into new areas following eradication success at Blackwater 2 ½ years ago
- Chronic Wasting Disease (CWD)
  - Deer, moose, elk in CO
  - Positives in NY PA WV
  - MD DNR is monitoring in MD, on false positive in 2008
- Two bills in 2008 session (legislation also posted on http://www.mdinvasivesp.org/legislation.html)
  - HB226 bait authority expanded
  - http://mlis.state.md.us/2008rs/billfile/HB0226.htm
  - HB630 expand authority to manage invasive nuisance species that have become established

  - Invasive Species Matrix Team is developing police for not planting exotic invasive plants on state land or projects - would like agenda item at future MISC meeting
