Didymo – update and decisional re: MISC endorsement of DNR proposed gear restrictions, Jonathan McKnight

- "Rock Snot"
- Viscous brown substance covers 80% of stream floor in prime habitat same as trout
- Thought to be native to Scotland, moves quickly around world (VT, AK first)
- Moves on feet of fly fishermen coarse felt soles of waders viable for 3 weeks
- DNR has set up wader wash stations 5% salt solution in vat lethal to didymo, signage is educational
- Simms, Orvis, LL Bean have stopped making felt soled waders new technologies
- Low end waders still felt soled
- Found in Gunpowder River last year many desirable fishing streams at risk in MD.

- Positive test for lower Savage no algal growth or mats; dam repair so very little flow may prevent growth
- Primary Goals reach fly fishing community
- DNR would like to ban felt soled waders in MD a/o Jan. 1 next year DNR has wader protocol, biosecurity restrictions for field workers
- Restriction would also protect against whirling disease, VHS virus, other unanticipated invasives
- DNR authorized by law to restrict fishing gear in regulation want to ban use, not sale, one year phase-in
- AK and VT are also proposing similar restrictions
- Banned in New Zealand ~5 years ago
- Wants 1)resolution from MISC supporting ban, 2)MOU with SHA for salt for wader washers

Discussion:

- Control? None. Will die back when water warms up
- Effects of road salt? haven't seen any yet, still learning about didymo in MD through monitoring
- Effects people don't want to fish infested streams; known to affect stream invertebrates
- What is fly fishing worth in MD? Will get answer.
- Suggestion: trade-in program
- Concern re Initial impacts on small business want to get word out quickly
- Support for resolution Jonathan will share The Science of Felts, Maryland impacts, justification
- MISC procedures Once Jonathan gets information out, John Lydon will send out to listsery for vote

Agency Updates

MDA – Dick Bean, Bob Trumbule, Carol Holko

- Pine shoot beetle
 - o started trapping in 1994
 - Garrett, Allegany, Frederick, Montgomery, Washington Counties previously positive
 - o 2010 outbreak Baltimore, Carroll, Harford, Howard Counties positive
 - o Revised guarantine to be issued next week
- Weed biocontrol programs PLS beetle rearing extremely successful; MAM weevil rearing moving forward
- CAPS activities surveys for exotic wood boring beetles, suite of grape pests, giant hogweed, imported fire ant, *Sirex noctilio*
- Farm Bill surveys for plum pox virus, sudden oak death, expansion of grape survey
- Emerald ash borer survey ~2,800 traps out this year
 - o Recovery of one (*Tetrastichus planipennisi*) of the three species of parasitoids released in 2009
- Snails Mediterranean species, chocolate banded snail, discovered at private terminal
 in Baltimore on shipment of titanium machine parts from Russia; snails probably not on
 shipment appears to be established on site; traced back from PA and WV receivers;
 MDA, PPQ, CPB joint effort to mitigate problem on site, determine where shipments
 have gone; currently not considered "actionable" by PPQ; Matt has asked for another
 pest risk assessment,

MDNR – Kerrie Kyde, Jonathan McKnight, Ann Hairston-Strang

- Blue catfish in Nanticoke and Patuxent Rivers
- Snakehead reported into St. Jerome's Creek
- Do Not Plant list in Secretary's office for approval
- MD Biological Stream Survey collecting data on invasive species, graded by density; 5
 years of data on 26 species
- Working with areas damaged by hemlock woolly adelgid to get other tree species and treated hemlocks established

MDE – Chris Luckett

• Grad student doing a study on MD's way of dealing with aquatic invasive species wants to do interviews with relevant parties

MDE – Chris Luckett – no report

<u>UM Extension – Brian Clark</u>

- Confirmed late blight on tomato seedlings in St. Mary's County samples to APHIS
- Solanaceous crops at risk
- Grown on site from seed, only sold in MD
- MD has vegetable transplant regulations requiring documented certification of transplants from other states
- Doesn't overwinter here unless two mating subspecies combine this early in the season probably didn't blow up from South

- Farm Bill funding request for suggestion; EDRR fits in mitigation; Open May 3 June 17;

- Lygodium added to fnw list as of May 3
- Earth Day event at APHIS HQ
- Releasing SC from witchweed quarantine
- SITC trace forward selling goat's rue across state lines, federal noxious weed
- SITC trace forward orange jasmine from FL shipped to MD nursery, violation of federal citrus quarantine
- Port alert high number of CBP emergency action notices on wood packing material from India, primarily pipe and tubing shipments for wood boring beetles
- New Investigative and Enforcement Services (IES) officer in MD
- \$385K fine assessed for FL nursery that shipped IFA to MD in 2006 can no longer ship out of quarantine area

<u>ARS</u>

- BARC field day June 5, 2010
- Phil Tipping (formerly with MDA), ARS FL, has permission to release water hyacinth leafhopper for biocontrol

News and New Business

John Peter Thompson – working on certification of nursery stock as vector for plant pests and forest certification programs

Bud Reaves – flowering red form of *Imperata cylindrica* "red baron" observed (Carol has observed same – not viable seed

TNC – outside funded summer field crews in preserves to control infestations of invasive plants - expanding to points of entry and spread; Mary Travaglini is working on invasive species control on NPS land; controlled burns in xeric dunes and understory loblolly pine plantations led to explosion of *Lespidesa*.
