Agency Updates

APHIS - Al Tasker (not present – notes provided by Al, presented by John)

• The final rule revising the APHIS weed rule Weed Final Rule APHIS 2007-0146-15 issued November 10, 2010; Effective Date: December 10, 2010.

We are amending the regulations governing the importation and interstate movement of noxious weeds by adding definitions of terms used in the regulations, adding details regarding the process of applying for the permits used to import or move noxious weeds, adding a requirement for the treatment of Niger seed, and adding provisions for petitioning to add a taxon to or remove a taxon from the noxious weed lists. These changes will update the regulations to reflect current statutory authority and program operations and improve the effectiveness of the regulations. We are also adding seven taxa to the list of terrestrial noxious weeds and to the list of seeds with no tolerances applicable to their introduction. This action will prevent the introduction or dissemination of these noxious weeds into or within the United States. (Alan Tasker, National Program Manager, 734-5708).
