It was also discussed and agreed upon that draft minutes should only be sent to members who attended the meeting.

Also discussed was the need for a new Recording Secretary. It was suggested that Kevin Wilsey, SHA He might be a fit since he does a great job as R.S. for IPAC. Nomination of Mr. Wilsey deferred until the next MISC meeting.

<u>Membership</u> To be considered for membership, one must attend at least two meetings, not necessarily consecutively. Mark Taylor and Karen Rane met these requirements and were unanimously accepted as new members of MISC.

Agency Updates

- USDA: Jim Young-presented "New Pest Interceptions" (see handout/attached pdf)
- Matt Travis-mentioned that lots of hitchhikers are arriving through the winter on tile imported from overseas. Spotted lanternfly on cargo via rail from Canada. EAB noted attacking Chionanthus; Proposals and Review for Farm Bill now closed; US Govt. has continuing resolution through Dec 11th
- DNR: Jay Kilian -- Zebra Mussel update. In Susquehanna; Peach Bottom first found 2010. Now below Conowingo 2014. Numbers of larval stage found increasing exponentially. Over 13K found in Susquehanna flats. Asian swamp eel, banned by DNR, found in Lake Needwood, July 2014
- Kerrie Kyde-reported on Invasive Plant Advisory Committee (IPAC). Still working on the "Tier I" and "Tier 2" Lists/evaluations. Sylvan Kaufman and J.P. Thompson MISC members also on IPAC. Sylvan K.- Looking for areas where rare or threatened species are being overrun by invasive species.
- U of MD: Karen Rane, Dave Clement- Boxwood blight- Now four MD landscape finds. Also one in D.C. Karen believes that weather is the primary contributor to uptick in detections. Were perfect conditions this year for development of the disease. Reported first U.S. find of the disease on *Sarcoccca*. Matt Travis- Working with APHIS and his counterparts in Canada at trying to stop the disease at the source. There may be an opportunity for states (i.e. MD) to apply for FRSMP(?) a federal program that helps prevent the introduction of pests/diseases through international trade.
- MDA: Bob Tatman- Gypsy Moth; low numbers. No treatments planned. Saw lots of Spotted Lanternfly on recent trip to S.E. Pennsylvania. Dick Bean-Thousand Cankers Disease of Walnut; Quarantine proposed for parts of Cecil County, MD. Will include all Juglans spp. PA accepting walnut from MD only with certification of county of origin(not Cecil). Quarantine would eliminate need for certification of individual shipments. Bob Trumbule- Mile-a-minute weed biocontrol update; report of first find of Viburnum Leaf Beetle in MD; Garrett County.

- Ruth Hanessian, MD Assn. of Pet Industries: Reported on next Science Café (?)
- Sylvan Kaufman: Reported on upcoming webinar on Chespeake Landscap.org. January 7; Tools For Invasive Plant Control
- Anne Arundel Co.: Bud Reaves-EAB treatments started in Jug Bay. Treated State champion trees.
- Kerrie Kyde, reported that the State Highway Administration (SHA) is currently having trouble with the Maryland Department of Environment (MDE). MDE is declaring roadside ditches as wetlands, especially along Route 50, so SHA cannot do necessary work there including weed management, mowing, etc. Asked if MISC would consider writing a

letter. It was decided that MISC would draft a letter(?). It was also suggested that the facilitator should invite someone from MDE to attend a MISC meeting. (Voted on? yes?)

- John Peter Thompson, Talked about conference call(?)
- Matt Salo, Cheverly: Three levels of invasives in Cheverly; Those he cannot deal with, those where they have had marginal success at management, and those where they have good success.
- MNCPPC: Carole Bergmann- Now beginning in certain areas, after many years of battling invasive plant species, to plant native plants that are being grown at Pope Farm. Weed Warriors now have clocked 70K hours of work. Equivalent to 35years!

- Marc Imlay, Sierra Club, MAIPC Board: Reported on control of Japanese knotweed; 20% foliar coverage of systemic herbicide (?) on leaf undersides gives 100% control. Three species very problematic: Japanese stiltgrass, wavyleaf basketgrass, beefsteak plant. New research on biocontrol. Mike Ellis-asked that members look for wavyleaf basketgrass disease or insects
- Mike Sowers, reported on "Barberry brigade" work at Catoctin Mountain park Impressive effort by youth groups.
